PRIOR TO THE BOARD, HE MUST CALL THE SCOUTMASTER TO ARRANGE FOR A SCOUTMASTERS CONFERENCE. THE CONFERENCE MAY TAKE PLACE ON THE SAME DAY AS THE BOARD, BUT THERE IS NOT A GUARANTEE OF PASSING THE FIRST TIME. ALL OF THESE FORMS, PLUS THE SCOUTS HANDBOOK, RESUME, AND PATROL SCRIBE BOOK MUST BE PRESENT AT ALL BOARDS AND CONFERENCES. EAGLE SCOUT RANK CANDIDATES HAVE ADDITIONAL REQUIREMENTS THAT WERE BROUGHT TO YOUR ATTENTION DURING THE ROAD TO EAGLE SEMINAR.
